

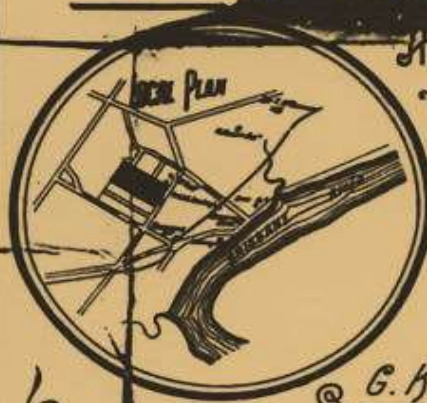
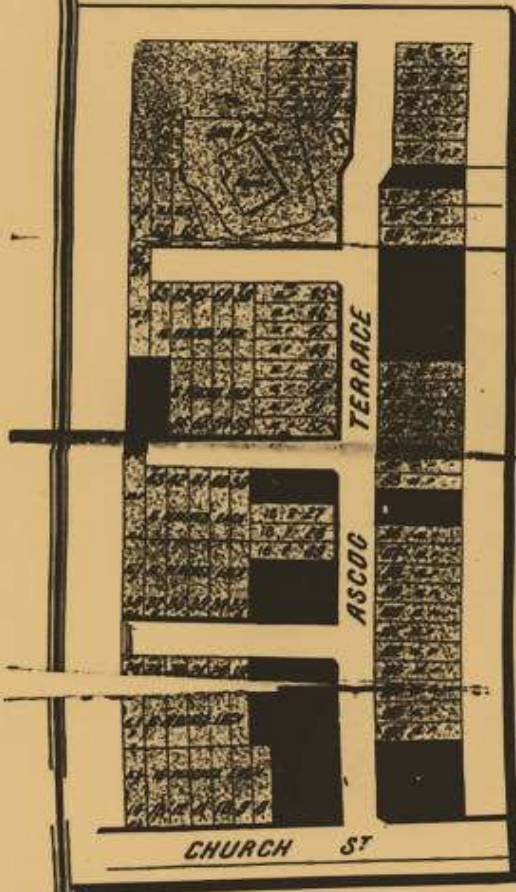

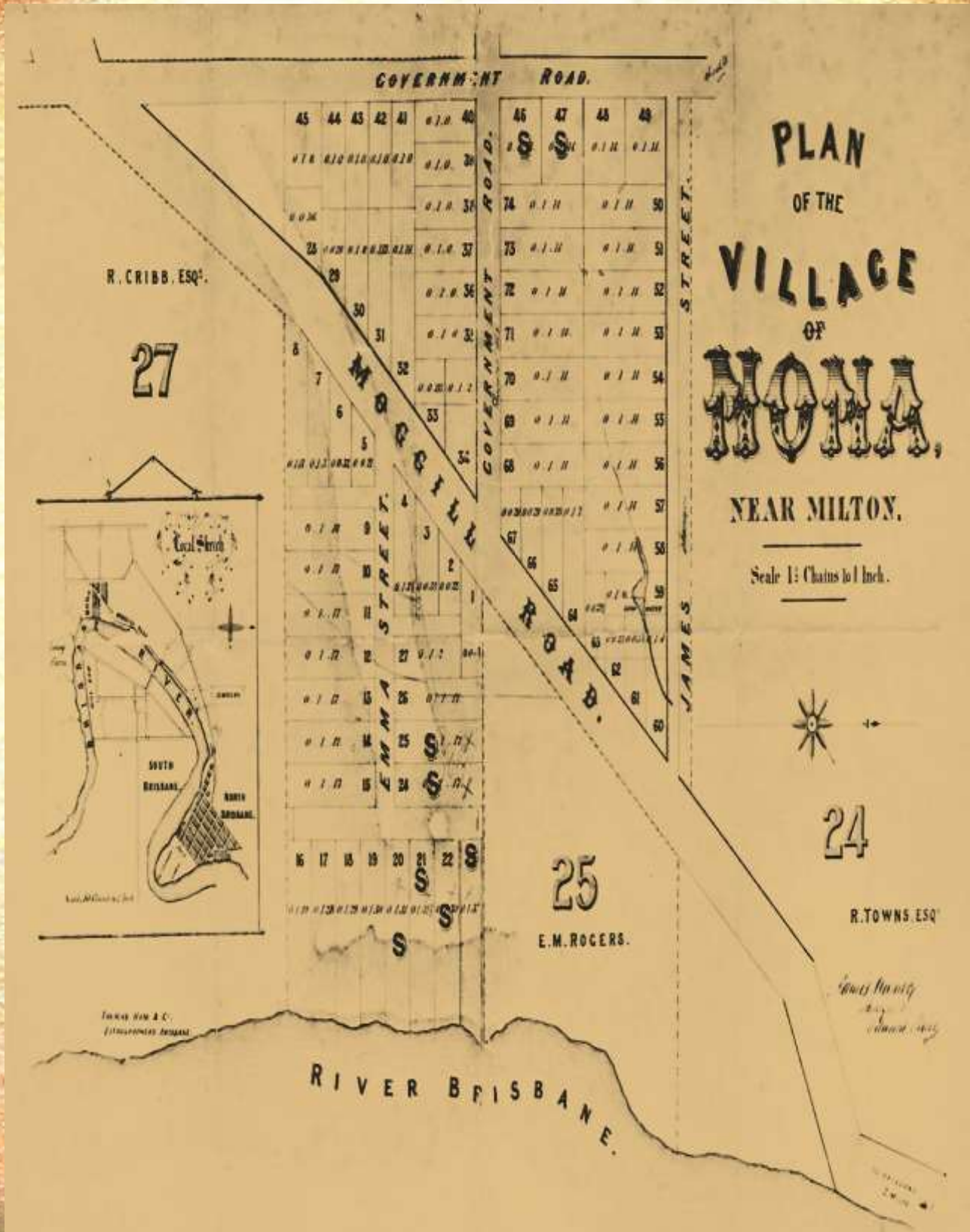
### ASSISTANCE TO BUILD.
